WHEREAS, the Sheriff-Coroner's Federal Asset Forfeiture Organization 1459 requires \$1,400,000 to meet expenditures associated with replacing Helicopter Eagle One; and

WHEREAS, \$1,400,000 is available in the fund balance of the Special Revenue Sheriff-Coroner's Fund 0095, Subclass, 17658 to fund these expenditures; and

WHEREAS, \$1,400,000 is not included in the FY 2015-16 adopted appropriations of the Sheriff-Coroner's Federal Asset Forfeiture Org 1459; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2015-16 Sheriff-Coroner's- Special Revenue Fund 0095, Subclass 17658, Federal Asset Forfeiture Org 1459 as follows:
