RESOLUTION

WHEREAS, the Alcohol Abuse Ed & Prev – SB920 ORG 1061 requires \$22,125 to meet expenditures; and

WHEREAS, the Alcohol Abuse Ed & Prev – SB920 ORG 1061 requires an increase in appropriations to fund an Operating Transfer Out in the amount of \$22,125 to the Behavioral Health Org 5630; and

WHEREAS, sufficient funds are available in the Fund Balance of the Dept of Behavioral Health fund 0041, Subclass 17111, Org 1061 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2024-25 Alcohol Abuse Ed & Prev – SB920 ORG 1061; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Alcohol Abuse Ed & Prev – SB920 ORG 1061 as follows:
