Subject: Proposed dog law

Report Suspicious

Good Morning, How would the proposed dog and cat breeding law be enforced when the law conflicts with zoning, where commercial and private kennels are allowed in parts of the unincorporated county of Fresno as part of their land usage per the zoning code?

Will you provide enforcement officers a copy of each property's zoning and any use permits pulled through the Department of Public Works and Planning, to determine whether the law is enforceable for that specific property based on zoning regulations?

Most properties in Fresno county either come with a private kennel with a by right usage, or allow the owner to apply for a Use Permit from the department of public works and planning to operate either a commercial kennel (multiple litters of dogs) or a private kennel (incidental litters of dogs). Sales of dogs and cats are also allowed based on zoning and land usage within Fresno county, by definition, as stated in the zoning ordinance.

The law regulating dog and cat breeding would be illegal and unenforceable on parcels where they are permitted to have multiple litters of dogs and based on their zoning and any use permits obtained. Enforcing a law on a property zoned for dog breeding would be taking away the land usage rights granted in the zoning code. This is illegal.

What about USDA pet transport services? Will Fresno county have the authority to impose a fine on a USDA licensed pet transport services delivering a dog within the unincorporated county of Fresno? USDA is federal and those pet transport services have a legal right, per federal law, to deliver dogs to anyone in the unincorporated area who may have purchased a dog from another city or state. This law seems like it would be difficult to enforce, as it would be illegal to enforce in many parts of Fresno county as it conflicts with zoning and a property owner's land usage rights as outlined in the zoning code.
