OF \$350,000)

WHEREAS, the County of Fresno, GSD - Fleet Services, Organization (Org) 8910, requires an increase in appropriations in the amount of \$350,000 to allow for the payment of rental equipment and tools to maintain and repair County buildings and grounds as necessary to meet departmental needs and demands; and

WHEREAS, said additional costs will be financed by revenue from user County Departments benefiting from said services in the amount of \$350,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2025-26 GSD - Fleet Services, Org 8910 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2025-26 GSD - Fleet Services, Org 8910 as follows:


