WHEREAS, the District Attorney received FY2022-23 funds from the California Department of Insurance for the Disability and Healthcare Fraud Program in the FY2022-23; and

WHEREAS, the funds received were \$125,749 more than what was included in the adopted appropriations and estimated revenues of the District Attorney-Grants Org 2862 for the FY 2022-23; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2022-23 appropriations of the District Attorney-Grants Org 2862 as follows:


