WHEREAS, the Department of Behavioral Health Organization 5630 will receive \$3,202,228 as an Operating Transfer In from the Local Health and Welfare Trust Special Revenue Fund 0135, 1991 Realign - Health Organization 5243; and

WHEREAS, \$3,202,228 is not included in the FY 2016-17 adopted appropriations and estimated revenues for the Behavioral Health Organization 5630; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;




