Dyer has received recognition throughout California and the nation and was selected as the California Police Chiefs Association President in 2008; through his selection by the Governor of California to the Governors' Gang Reduction Intervention Program Advisory Board; and as a Board member of the National Major Cities Chiefs Association among the many other leadership roles over his career; and

Dyer has, throughout his career, committed to improving the safety of his officers by building a state-of-the-art Regional Law Enforcement Training Center; establishing the Real Time Crime Center using the latest technologies available to law enforcement to provide critical information to officers in the field; implementing Data Driven and Predictive Analytics to more efficiently deploy resources; established the SKYWATCH aviation unit adding substantially to officer and community safety; and has worked tirelessly to build trust with our diverse community through a tireless commitment to community policing principles.
