WHEREAS, the Integrated Waste Management 1156 requires \$228,972 to meet expenditures associated with Waste Management Enforcement and DA Waste Tire Investigator, recognizing \$3,164 as prior year grant funds, \$25,808 Local Enforcement Grant, and \$200,000 UC Davis Spay & Neuter Grant; and

WHEREAS, \$3,164 is available in the fund balance of Special Revenue Fund 0080, Subclass 17356, Integrated Waste Management Organization 1156 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Special Revenue Fund 0080, Subclass 17356, Integrated Waste Management 1156; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Integrated Waste Management 1156 as follows:
