The agreement is for five consecutive years, which includes a three-year base contract and two optional one-year extensions for \$270,000. The annual maximum is \$54,000.

Fresno County Sheriff's Office has been using VMS since 2015 and have received no complaints from staff and/or employees. We have an established relationship with Victoria Smith Sanders (licensed marriage and family therapist). We are confident Sanders and her practice understand the unique stressors associated with the law enforcement community. The Sheriff's Office wants this vendor for the continuity of care with current patients.

In an emergency when goods or services are immediately necessary for the preservation of the public health, welfare, or safety, or for the protection of County property.

When the contract is with a federal, state, or local governmental agency.

When the department head, with the concurrence of the Purchasing Agent, finds that the cost of preparing and administering a competitive bidding process in a particular case will equal or exceed the estimated contract amount or \$1,000 whichever is more.

When a contract provides only for payment of per diem and travel expenses and there is to be no payment for services rendered.

When obtaining the services of expert witnesses for litigation or special counsel to assist the County.

When in unusual or extraordinary circumstances, the Board of Supervisors or the Purchasing Agent/Purchasing Manager determines that the best interests of the County would be served by not securing competitive bids or issuing a request for proposal.

- 6. Explain why the unique qualities and/or capabilities described above are essential to your department. Employees in the law enforcement profession are often placed in the most stressful incidents known to both the public and private sector. These particular incidents have been known to impact an employee's mental and physical health. Whenever possible, we seek to provide our employees with safe and effective resources to foster a healthy and constructive working and/or personal environment.
