ORDINANCE NUMBER 21-010

AN ORDINANCE AMENDING SECTION 4300-INFORMATION TECHNOLOGY SERVICES OF THE MASTER SCHEDULE OF FEES, CHARGES, AND RECOVERED COSTS FOR THE COUNTY OF FRESNO, WHERE SUBSECTIONS 4302-4305, 4308-4310, 4313-4315, 4317, 4320-4323 AND 4326-4330 ARE AMENDED.

The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1: The Master Schedule of Fees, Charges and Recovered Costs for the County of Fresno, Section 3800 – General Services, is hereby amended, by amending subsections 4302-4305, 4308-4310, 4313-4315, 4317, 4320-4323 and 4326-4330, relating to the recovery of costs for Information Technology Services of the Internal Services Department (ISD) to County departments and other public agencies, as set forth in Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2: This ordinance shall take effect thirty (30) days from the date of its final passage.
