WHEREAS, the County of Fresno, Information Technology Services, Organization (Org) 8905 requires an increase in appropriations in the amount of \$1,159,000 to allow for the payment of costs related to outfitting, maintaining and securing the building and the technological systems housed within it located at 333 W. Pontiac Way and; and

WHEREAS, \$1,159,000 is available in the retained earnings of the Information Technology Services Fund 1020, to fund the costs related to outfitting, maintaining and securing the building and the technological systems housed within it located at 333 W. Pontiac Way; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2017-18 Information Technology Services, Org 8905 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2017-18 Information Technology Services, Org 8905 as follows:




