WHEREAS, the Library-Measure B Organization 7511 requires additional appropriations in the amount of \$58,500 for Fleet expenses to transition the existing Fleet Winnebago No. 33613 to a Digibus Mobile Classroom; and

WHEREAS, the development of the Digibus Mobile Classroom will require interior and exterior related expenses; and

WHEREAS, the \$58,500 is available in the Fund Balance of the Fresno County Library-Measure B Fund 0107, General Subclass 10000; and

WHEREAS, the Fresno County Library-Measure B fund shall be used exclusively for public library construction, acquisition, programs, and operations within the County; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations of the Library-Measure B Organization 7511; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Library-Measure B Organization 7511 as follows:
