AN ORDINANCE AMENDING THE MASTER SCHEDULE OF FEES, CHARGES AND RECOVERED COSTS FOR COUNTY SERVICES ("MASTER SCHEDULE OF FEES"). THIS ORDINANCE AMENDS SECTION 2800 (SOLID WASTE), ADDING SUBSECTION 2807 (PUBLIC WORKS AND PLANNING), RELATING TO THE RECYCLING HAULERS REGISTRATION ADMINISTRATION FEE.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1: The County of Fresno Master Schedule of Fees, Charges and Recovered Costs Ordinances is hereby amended as to Section 2800, adding Subsection 2807, paragraph (a) to read in its entirety as set forth in Exhibit 1, attached hereto and incorporated by reference.

Section 2: This ordinance shall take effect and be in force on April 1, 2017.

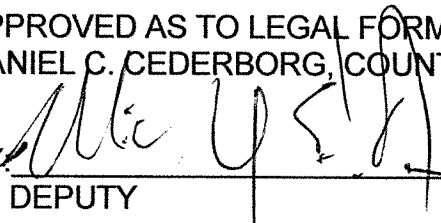

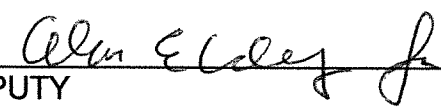
