Operating Transfer In from the Inmate Welfare Special Revenue Fund Org 1500  
to fund the costs associated with the Inmate Services Director position; and

WHEREAS, said monies are not included in the FY 2016-17 adopted  
appropriations and estimated revenues of the Sheriff-Coroner's Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the  
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-  
Tax Collector is authorized to increase the appropriations in the FY 2016-17  
Sheriff-Coroner's Org 3111 as follows:
