WHEREAS, the Social Services Fund 0065, Welfare Advance Fund Organization 1120 will receive \$377,294 in Federal and State funds to meet the need as Operating Transfer Out to the Department of Social Services to cover additional positions for CalWORKs assistance and IHSS financial services; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Welfare Advance Fund Organization 1120 as follows:
