WHEREAS, the Sheriff-CA St Corr Train Org 1452 requires \$109,384 to meet expenditures associated with core training courses for Correctional Officers; and

WHEREAS, \$109,384 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Subclass 17652 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2017-18 adopted appropriations of the Sheriff-CA St Corr Train Org 1452; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff-CA St Corr Train Org 1452 as follows:


