A RESOLUTION AUTHORIZING THE COUNTY OF FRESNO TO SUBMIT A GRANT APPLICATION TO THE NOTICE OF FUNDING OPPORTUNITY THROUGH THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT CONTINUUM OF CARE PROGRAM COMPETITION

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has issued a Notice of Funding Opportunity (NOFO), dated November 13, 2025, for the Continuum of Care Program Competition (CoC Grant);

WHEREAS, the County of Fresno, a political subdivision of the State of California (County), desires to apply for the CoC Grant funds and will be submitting one application by the deadline of January 14, 2026, to HUD for review and consideration; and

WHEREAS, the HUD grant application procedures require, among other things, an applicant's governing body to authorize by resolution its approval for submittal of grant applications and participation in CoC Grant on behalf of the County of Fresno; and

WHEREAS, if awarded, the County will enter into a CoC Grant Agreement for the implementation of said grants; and

NOW THEREFORE, the Board of Supervisors of the County of Fresno authorizes the submittal of one (1) application to HUD in response to the NOFO for CoC Grant funds in a total amount not to exceed \$1,000,000 ("Application").

NOW THEREFORE, if the Application is approved, the County is hereby authorized and directed to enter into, execute, and deliver a CoC Grant Agreement, and all other documents required or deemed necessary or appropriate to secure the grant funds from HUD and to participate in the CoC Grant program, and all amendments thereto.

NOW THEREFORE, if funding is awarded and the CoC Grant Agreement is approved by the County's Board of Supervisors, then the County acknowledges and agrees that it shall be

1 subject to the terms and conditions specified in the CoC Grant Agreement. Any and all activities,
2 expenditures, information, and timelines represented in the Application are enforceable through
3 the CoC Grant Agreement. Funds are to be used for the allowable expenditures and activities
4 identified in the CoC Grant Agreement.

5 **NOW THEREFORE**, the Chairman of the County's Board of Supervisors, is authorized
6 to execute the Application.

7 **NOW THEREFORE**, the County Administrative Officer is authorized to execute all other
8 documents required or deemed necessary or appropriate to secure the CoC Grant funds from
9 HUD and to participate in the CoC Grant program, with the exception of the CoC Grant
10 Agreement on behalf of the County.

11 **BE IT FURTHER RESOLVED**, the Chairman of the Board of Supervisors of the County
12 of Fresno, is hereby authorized and empowered to execute on behalf of the County all CoC
13 Grant documents including but not limited to, the Application and Program Funding Agreements.
