WHEREAS, the County of Fresno will receive \$2,180,000 from various third parties to fund a portion of the new helicopter; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the Sheriff-Coroner Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the Fiscal Year 2015-16 Sheriff-Coroner Org 3111 appropriations as follows:
