

1 AMENDMENT I TO AGREEMENT

2 THIS AMENDMENT I TO AGREEMENT, ("Amendment I"), is made this 4th day of
3 August, 2020 ("Effective Date"), by and between the COUNTY OF FRESNO, a political
4 subdivision of the State of California, ("County"), and the CITY OF KINGSBURG, ("City").

5 WITNESSETH

6 WHEREAS, the County has been designated as the sponsoring agency to administer and
7 implement the Community Development Block Grant (CDBG) Program activities of the County,
8 and its participating cities, in accordance with the provisions of Title I of the Housing and
9 Community Development Act of 1974, as amended, and the laws of the State of California; and

10 WHEREAS, on November 19, 2019, the County and the City entered into Agreement 19-
11 597, ("Agreement"), whereby \$189,960 in CDBG funds were made available to the City for the
12 Kingsburg Senior Center Improvements, Project No. 19391 ("Project"); and

13 WHEREAS, the City had previously committed local funds to the Project in the amount of
14 \$47,540; and

15 WHEREAS, the City informed the County that the total estimated cost of the Project has
16 increased from \$237,500 to \$279,332 due to increased construction costs; and

17 WHEREAS, the City would like to utilize an additional \$89,372 in CDBG funding to
18 complete the Project instead of utilizing local funds; and

19 WHEREAS, the City now has an additional \$89,372 from its allocation of CDBG funds that
20 may be made available to the Project to accommodate the increased construction costs under the
21 Agreement; and

22 WHEREAS, the City has requested these additional CDBG funds in the amount of \$89,372
23 be made available to the Project for the purposes of this Agreement.

24 NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the
25 City and the County agree to amend the Agreement as follows:

26 1. Page 1 of the Agreement, Lines 14-19, is amended to read:

27 "WHEREAS, the City has estimated that total cost of the Project is \$279,332, and is in need
28 of \$279,332 in CDBG funding to complete the Project; and

1 WHEREAS, the County can provide \$279,332 in CDBG funds needed for the Project from
2 the City's 2019-2020 CDBG allocation (\$88,711), from the City's 2020-2021 CDBG allocation
3 (\$86,204), and from the City's remaining balance of CDBG funds (\$104,417); and"

4 2. The proposed Project budget on Page 2, Lines 17 through 20, is amended to read:

5 "Construction	\$201,000
6 Design & Construction Engineering	30,000
Contingency, Permits & Misc.	<u>48,332</u>
7 Total	\$279,332"

8 3. The proposed funding summary for the Project on Page 2, Lines 26 and 27, is
9 amended to read:

10 "CDBG	\$279,332
11 Local Financial Contribution	<u>0</u>
Total	\$279,332"

12 4. That the dollar figure set forth on Page 2, Line 23, Page 3, Line 13, and Page 4,
13 Line 17, is amended in each such place to read "\$279,332".

14 County and City agree that this Amendment I is sufficient to amend the Agreement,
15 and that upon execution of this Amendment I, the Agreement and this Amendment I together shall
16 be considered the Agreement.

17 The Agreement, as hereby amended, is ratified and continued. All remaining provisions,
18 terms, covenants, conditions, and promises contained in the Agreement shall remain in full force
19 and effect.
