11 **WHEREAS**, the Recommended Budget of the County of Fresno, State of California (the
12 "County"), for the period between July 1, 2024 and the Board of Supervisors' adoption of the
13 Fiscal Year (FY) 2024-25 Final Recommended Budget has been prepared, made available for
14 public distribution, and distributed according to law; and

15 **WHEREAS**, notice that the Recommended Budget of the County for the period between
16 July 1, 2024 and the Board of Supervisors' adoption of the FY 2024-25 Final Recommended
17 Budget has been so prepared and made available for public distribution, specifying the time and
18 place of the Board of Supervisor's hearing, has been published on June 7, 2024, in The
19 Business Journal, a newspaper of general circulation, for the time in the manner required by
20 law; and

21 **WHEREAS**, the Recommended Budget of the County for the period between July 1, 2024
22 and the Board of Supervisors' adoption of the Fiscal Year (FY) 2024-25 Final Recommended
23 Budget includes Capital Project budgets; and

24 **WHEREAS**, a hearing upon the Recommended Budget of the County for the period
25 between July 1, 2024 and the Board of Supervisors' adoption of the FY 2024-25 Final
26 Recommended Budget was held by the Board of Supervisors as described in the published
27 notice of hearing, at which hearing items of the Recommended Budget were considered and
28 discussed and all additions and deletions to the Recommended Budget were made; and

1 **WHEREAS**, before taking action under this Resolution, members of the public were given
2 the opportunity to appear at the hearing of the Board of Supervisors and be heard regarding any
3 item in the Recommended Budget of the County for the period between July 1, 2024 and the
4 Board of Supervisors' adoption of the FY 2024-25 Final Recommended Budget or for the
5 inclusion of additional items; and

6 **WHEREAS**, the Recommended Budget of the County for the period between July 1, 2024
7 and the Board of Supervisors' adoption of the FY 2024-25 Final Recommended Budget, as
8 adjusted by the Board of Supervisors at the conclusion of the public budget hearing, contains
9 the specific requirements of Government Code section 29089.


10 **NOW, THEREFORE, BE IT RESOLVED**, that the Recommended Budget of the County for
11 the period between July 1, 2024 and the Board of Supervisors' adoption of the FY 2024-25 Final
12 Recommended Budget, as amended during the Board of Supervisors' public hearing, be and is
13 hereby adopted as the Budget of the County for the period between July 1, 2024 and the Board
14 of Supervisors' adoption of the FY 2024-25 Final Recommended Budget for all funds governed
15 by the Board of Supervisors, which document is adopted by reference, as provided for the
16 Government Code Section 29090, and made a part of this Resolution.
