WHEREAS, the Waterworks District 40 Organization will receive \$89,235 in revenue from assessments levied on benefitting properties of Shaver Springs to pay for the cost associated with the ongoing water system improvement; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2016-17 Waterworks District 40 Organization 9360; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriation of these funds by a 4/5ths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer – Tax Collector is authorized to increase the appropriations in the FY 2016-17 Budget for Waterworks District 40 Organization 9360 as follows:




