RESOLUTION

WHEREAS, the County Clerk-Elections Org 2850 requires an increase in appropriation in the amount of \$160,000 to fund special election costs related to filling the vacated Fresno Unified School District Trustee District Five and the vacancy for the West Park Elementary School District; and

WHEREAS, Fresno Unified School District and West Park Elementary School District have agreed to pay all election costs incurred; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the County Clerk-Elections Organization 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 County Clerk -Elections Organization 2850 as follows:
