WHEREAS, additional appropriations are required by Public Works and Planning, Parks and Grounds Org 7910 to provide funding for unanticipated expenditures related to maintenance work performed at the Juvenile Justice Campus (JJC); and

WHEREAS, Misc. Passthrough Org 43601250 has anticipated Professional & Specialized Services savings in the amount of \$100,000; and

WHEREAS, Support Serv-Human Resources Org 43651500 has anticipated Professional & Specialized Services savings in the amount of \$50,000; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Public Works and Planning, Parks & Grounds Org 7910; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Budget for the Public Works and Planning, Parks, Parks & Grounds Org 7910 as follows:




