RESOLUTION

WHEREAS, the 1991 Realign-Behavioral Health Org 5245 requires \$10,962,630 to meet expenditures; and

WHEREAS, the 1991 Realign-Behavioral Health Org 5245 requires an increase in appropriations and estimated revenues to fund an Operating Transfer Out in the amount of \$10,962,630 to the Behavioral Health Org 5630; and

WHEREAS, the Department of Behavioral Health will receive funds for the FY 2023-24 1991 Realign-Behavioral Health Org 5245; and

WHEREAS, said monies were not included in the adopted appropriations and estimated revenues for the FY 2023-24 1991 Realign-Behavioral Health Org 5245; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 1991 Realign-Behavioral Health Org 5245 as follows:
