RESOLUTION AUTHORIZING
RESCISSION OF AGRICULTURAL LAND
CONSERVATION CONTRACT (ALCC) NOS.
3044, 3045, AND 3046 AND ENTRY INTO
NEW ALCC NO. 8349

WHEREAS, Agricultural Land Conservation Contract (ALCC) Number 3044 was entered into between the County of Fresno and Warren D. George and Helen L. George, and succeeded to by Four W Farms LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 17, 1971 as Instrument Number 11895, Book 5863, Pages 255 through 257 in the Official Records of Fresno County, California; and

WHEREAS, ALCC Number 3045 was entered into between the County of Fresno and Warren D. George aka W. D. George and Helen L. George, and succeeded to by Four W Farms LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 17, 1971 as Instrument Number 11896, Book 5863, Pages 258 through 261 in the Official Records of Fresno County, California; and

WHEREAS, ALCC 3046 was entered into between the County of Fresno and Warren D. George and Helen L. George, and succeeded to by Four W Farms LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 17, 1971 as Instrument Number 11897, Book 5863, Pages 262 through 264 in the Official Records of Fresno County, California; and

1 WHEREAS, Owner proposed allowing the creation of seven (7) parcels from a 314.55-
2 acre (gross) parcel identified as APN 041-110-57S. The rescission of existing Agricultural Land
3 Conservation Contract Numbers 3044, 3045, and 3046 and simultaneous execution of new
4 Agricultural Land Conservation Contract Number 8349 is required to ensure the new contract
5 reflects the acreage of the proposed parcels; and

6 WHEREAS, California Government Code Section 51254 provides a process where
7 parties may upon their mutual agreement rescind a contract in order to simultaneously enter
8 into a new contract which would enforceably restrict the same property for an initial term at
9 least as long as the unexpired term of the contract being so rescinded but no less than 10
10 years, notwithstanding the prior serving of a notice of nonrenewal relative to the former
11 contract; and

12 WHEREAS, this rescission and re-entry would result in rescission of existing
13 Agricultural Land Conservation Contract Numbers 3044, 3045, and 3046 and simultaneous
14 entry into new Agricultural Land Conservation Contract Number 8349.

15 NOW, THEREFORE IT IS HEREBY RESOLVED that the Board of Supervisors of the
16 County of Fresno hereby approves rescission of Agricultural Land Conservation Contract
17 Numbers 3044, 3045, and 3046 and simultaneous entry into new Agricultural Land
18 Conservation Contract Number 8349, based on upon mutual agreement of the parties of the
19 contract pursuant to Government Code Section 51254, and approves and authorizes the
20 Chairman to execute the Rescission and Simultaneous Entry into New Land Conservation
21 Contract for Contract Number 8349 on behalf of the County; the Clerk of the Board of
22 Supervisors shall cause a certified copy of this resolution to be recorded together with
23 recordation of the fully-executed Rescission and Simultaneous Entry into New Land
24 Conservation Contract for Contract Number 8349 in the Office of the County Recorder for the
25 County of Fresno.



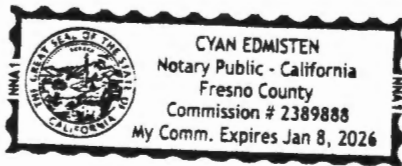
