WHEREAS, the Sheriff-Coroner Organization (Org) 3111 will receive \$80,000 as Operating Transfer In from the Sheriff-Coroner Special Revenue Fund 0095, Federal Asset Forfeiture Org 1459 to purchase an Intelligence-Led Policing Package; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Sheriff Organization 31113000; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff Organization 31113000 as follows:


