ORG 7910 IN THE AMOUNT OF \$254,982)

WHEREAS, Parks and Grounds Org 7910 will purchase equipment to be used for the
maintenance of various parks throughout the County of Fresno; and

WHEREAS, the County of Fresno received funds in the amount of \$754,285 from the Ernest
Lawrence estate on March 7, 2012, of which an additional \$254,982 is proposed to be allocated to
purchase equipment for various County operated parks; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and
estimated revenues of the Public Works & Planning, Parks & Grounds Org 7910; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriations of these
funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
authorized to increase the appropriations in the FY 2024-25 Budget for the Public Works & Planning,
Parks, Parks & Grounds Org 7910 as follows:
