

Suspension of Competition Acquisition Request



1. Fully describe the product(s) and/or service(s) being requested.

The services being requested are grouped into four major categories:

- 1. Provide software maintenance to department specific applications: PRIMS (Probation Information Management System), PERS (Defendant Portal), JPA (Justice Partner Portal), Sharenet (Law Enforcement Portal), which includes responding to issue/ticket within 24 hours; identify and resolve issues, and avoid re-occurrences; update legacy applications ensuring Probation application remain compatible with evolving technologies and platforms; provide application enhancements by adding and customizing new features, functions, and improvements; audit and verify existing codebase and add or improve code for enhanced performance; provide support with any hardware/software/server migrations; and security and performance optimizations.
- 2. Provide software development, which includes creating new systems and enhancements to existing Probation applications; test projects to verify process works properly when deployed; identify all dependencies required to deploy and configure into production; monitoring the system closely to find ongoing issues or changes and make adjustments to ensure optimum performance, create ADHOC reports and queries required for reporting; and work with County IT Security to ensure system configured as per County Standards.
- 3. Provide software integration, which includes data processes between department systems; implement County security standards to ensure data transmitted between systems are safe and accurate; create department process to send or receive data to meet standard and format of partnering entities; configure batch into production system per requirements and ensure proper operation, monitoring batch and API endpoint and resolve any identified issues; and provide integration updates.
- 4. Provide reporting and data requests, which includes gathering report requirements and validate output; develop and provide queries to generate reports as requested; validation of data results and optimization of queries to increase performance and efficiency; provide backup copies of queries; provide assistance for database migrations and analysis, and optimization of date to main data integrity and efficiency; development of data and table structures to normalize data as per County standards; and support data in various formats i.e. CSV, XML, JSON, etc.
