WHEREAS, the California Work Opportunity and Responsibility to Kids Org 6310 will receive \$1,749,353 in revenues as an Operating Transfer In from Welfare Advance Fund Org 1120 (\$1,749,353); and

WHEREAS, said monies are not included in the FY 2023-24 adopted appropriations and estimated revenues of the California Work Opportunity and Responsibility to Kids Org 6310; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifth vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Department of Social Services - California Work Opportunity and Responsibility to Kids Org 6310 as follows:
