ORDINANCE NO. 585

AN ORDINANCE AMENDING THE ORDINANCE CODE OF THE COUNTY OF FRESNO
BY ADDING CHAPTER 2.64 THERETO RELATING TO THE ESTABLISHMENT OF AN
ASSESSMENT APPEALS BOARD.

The Board of Supervisors of the County of Fresno do
ordain as follows:

Section 1. The Ordinance Code of the County of Fresno is
hereby amended by adding Chapter 2.64 thereto to be numbered,
titled, and contain the following sections to be numbered, titled
and read as follows:

2.64.010 Authority.

The creation of Assessment Appeals Boards, sometimes referred
to as Tax Appeals Boards, within counties to equalize the valuation
of taxable property within the county is authorized pursuant to
Section 9.5 of Article XIII of the Constitution of the State of
California and Article 1.5 commencing with Section 1620 of Chapter
1, Division 1, Part 3 of the Revenue and Taxation Code.

2.64.020 Board created.

There is hereby created an Assessment Appeals Board within the
County of Fresno to be designated Assessment Appeals Board No. 1,
which board shall consist of the number of members, be subject to
all the conditions of and have all the duties and powers as pro-
vided by the Constitution and laws of the State of California

1 referred to in Section 2.64.010 of this chapter as said laws now
2 provide and as they may in the future be amended.

3 2.64.030 Appointment.

4 The members of the Assessment Appeals Board and alternate
5 members shall be appointed directly by the Board of Supervisors.

6 2.64.040 Vacancies.

7 The Board of Supervisors shall appoint members and alternates
8 of the Assessment Appeals Board upon the expiration of any term of
9 office or the occurrence of a vacancy on such board. The person
10 selected to fill the vacancy shall serve the remainder of the
11 unexpired term.

12 Section 2. This Ordinance shall take effect and be in
13 force thirty days from and after its passage, and before the
14 expiration of fifteen days after its passage it shall be published
15 once with the names of the members voting for and against the
16 same in The Fresno Bee, a newspaper of general circulation
17 published in said County of Fresno.

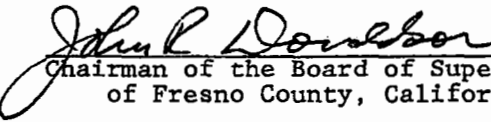
