RESOLUTION

WHEREAS, the County of Fresno, Purchasing, Organization (Org) 0440, requires an increase in appropriations in the amount of \$12,000 to allow for the payment of higher than budgeted retirement contributions in the current year; and

WHEREAS, Purchasing, Org 0440 has funds available from unanticipated revenues received during FY 2017-18 in the amount of \$12,000 from the sale of surplus to offset said additional costs; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 Purchasing, Org 0440 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2017-18 Purchasing, Org 0440 as follows:




