15 Department (ISD) to County departments and other public agencies, is hereby amended in its entirety
16 with the various subsections therein now reading as set forth in Exhibit 1, attached hereto and
17 incorporated herein by reference.

18 SECTION 2: This ordinance shall take effect thirty (30) days from the date of its final passage.

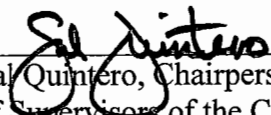

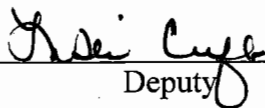
