WHEREAS, the County of Fresno will receive \$44,711 from U. S. Department of Justice (DOJ), Office of Justice Programs (OJP), Office of Juvenile Justice and Delinquency Prevention (OJJDP), for the Central California Internet Crimes Against Children (ICAC) Task Force Program, and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31116309; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Sheriff-Coroner-Public Administrator ORG 31116309 as follows:


