

Notice of hearing before the Board of Supervisors of the County of Fresno on **INITIAL STUDY APPLICATION NO. 6205** and **CLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3281** and **VARIANCE APPLICATION NO. 4023** filed by **OBADI KASSIM**, pursuant to Board of Supervisors direction.

Notice is hereby given that the Board of Supervisors of the County of Fresno has set this hearing for **Tuesday, the 4th day of June, 2019**, at the hour of **9:00 A.M.** (or as soon thereafter as possible), in the **Board of Supervisors Chambers**, Room 301, Hall of Records, 2281 Tulare St., Fresno, California, as the time and place for holding a public hearing on the following matter:

Allow an Agricultural Commercial Center consisting of a market with fuel sales and allow the creation of a 2.36-acre parcel and a 16.32-acre parcel from a 0.53-acre parcel and an 18.15-acre parcel by means of a property line adjustment in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The project site is located on the northeast corner of Conejo Avenue and Highland Avenue and is approximately 2 miles southwest of the nearest city limits of the City of Selma (SUP. DIST. 4) (APN 393-280-77S and 84S). Adopt the Mitigated Negative Declaration prepared for Initial study Application No. 6205 and take action on Classified Conditional Use Permit Application No. 3281 and Variance Application No. 4023 with Findings and Conditions.
