WHEREAS, funding from the Boating Safety and Enforcement Financial Aid Program helps support the provision of necessary law enforcement services on the waterways of Fresno County;

WHEREAS, Harbors and Navigation Code Section 663.7 and Title 14, California Code of Regulations Section 6593 together require that certain assurances be provided as a condition of receiving such financial aid;

WHEREAS, said revenue and appropriations in the amount of \$452,764 will be included in the Sheriff-Coroner-Public Administrator's FY 2025-26 budget request for Org 3111; and

NOW, THEREFORE, IT IS ORDERED that the Fresno County Sheriff's, or her/his designee's, prior submittal of an application to and acceptance of an award from the California Department of Parks and Recreation, Division of Boating and Waterways for the Boating Safety and Enforcement Financial Aid Program for FY 2025-26 in the funding amount of \$452,764 is hereby ratified, approved and authorized.

BE IT FURTHER RESOLVED, that the Chairman of the Board of Supervisors is hereby authorized and directed on behalf of the County of Fresno to execute the Boating Safety and Enforcement Financial Aid Program Agreement with the California Department of Parks and Recreation Division of Boating and Waterways for FY 2025-26 in the amount \$452,764.

BE IT FURTHER RESOLVED, that the Fresno County Sheriff, or her/his designee, is hereby authorized and directed on behalf of the County of Fresno to execute claims for reimbursement and annual activity reports of the Boating Safety and Enforcement Financial Aid Program for FY 2025-26.

1 BE IT FURTHER RESOLVED, that the County of Fresno is authorized to participate in the
2 FY 2025-26 Boating Safety and Enforcement Financial Aid Program, that it shall expend on
3 boating safety programs not less than an amount equal to 100% of the amount received by the
4 County of Fresno from personal property taxes on vessels, that the funds allocated to the County
5 of Fresno pursuant to the FY 2025-26 Boating Safety and Enforcement Financial Aid Program
6 shall only be used for boating safety and enforcement programs that are conducted in the County
7 of Fresno, and that the County Auditor is authorized to certify the amount of prior year vessel
8 taxes received by the County of Fresno.


