WHEREAS, the Sheriff Automated GC 26731 Org 1455 requires \$511,300 to meet expenditures associated with the replacement of a Civil Division software system platform and associated equipment, the outfitting of furnishings for Civil Division office space and the purchase of replacement computers for Civil Division staff; and

WHEREAS, \$511,300 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Sheriff Automated GC 26731 Subclass 17654 to fund these expenditures; and

WHEREAS, \$511,300 is not included in the FY 2019-20 adopted appropriations of the Sheriff Automated GC 26731 Org 1455; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


