RESOLUTION

WHEREAS, funds are needed to purchase property located at 650 O Street and 705 P Street, Fresno, CA 93721 (APNs 468-183-18U and 468-191-19U) to provide County office space in the current year; and

WHEREAS, the Hall of Records Improvements Organization (Org) 8861 has \$25,050,000 available for the purchase of the property; and

WHEREAS, the County Buildings Org 0131 will receive \$25,050,000 as an Operating Transfer In from the Hall of Records Improvements Org 8861 to purchase the property; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues for County Buildings Org 0131 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 County Buildings Org 0131 as follows:
