WHEREAS, funding is needed to complete the purchase of four vehicles to transport Jurors and other Court personnel to off-site crime scenes during jury trials and for other court related matters; and

WHEREAS, funds from prior years reserved AB 118 Trial Court Security Allocation in the amount of \$184,000 are available to fund the purchase; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations and estimated revenues of the Sheriff-Coroner Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Sheriff-Coroner Organization 3111 as follows:
