WHEREAS, the District Attorney’s Office, Organization (Org) 2860 has the opportunity to purchase four Sport Utility Vehicles (SUV) in the current year; and

WHEREAS, the District Attorney’s Office, Org 2860 has funds available in their FY 2021-22 budget for the purchase of four SUV’s in the amount of \$152,960; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$152,960 as an Operating Transfer In from the District Attorney’s Office, Org 2860 to purchase four SUV’s; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2021-22 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 ISD - Fleet Services Equipment Org 8911 as follows:
