SUMMARY

NOTICE is hereby given that at its regularly scheduled meeting on June 18, 2024, the Fresno County Board of Supervisors adopted Ordinance No. 24-010, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE

An ordinance amending Section 600 of the County of Fresno Master Schedule of Fees, Charges and Recovered Costs Ordinance – County Counsel, by amending Subsection 601 (renaming Legal Services as Attorney Services) relating to County Counsel's recovery of costs of attorney services (proposing to increase the fee rate for such services to \$169 per hour for each attorney) provided by County Counsel to County departments and other public agencies, and by adding Subsection 602 (Child Welfare Services (CWS) Legal Assistant Services) relating to County Counsel's recovery of costs of CWS Legal Assistant services (proposing a new fee rate for such services of \$72 per hour for each CWS legal assistant) provided by County Counsel to the County Department of Social Services; such ordinance amendment is proposed to be effective July 18, 2024.
