WHEREAS, the County of Fresno Department of Social Services In Home Supportive Services Organization 6420 will receive an additional \$8,687,792 in 1991 Realignment funds to offset the increase in mandated Maintenance of Effort (MOE) cost; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Department of Social Services In Home Supportive Services Organization 6420; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Department of Social Services In Home Supportive Services Organization 6420 as follows:

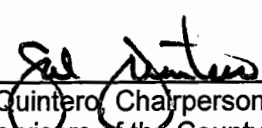

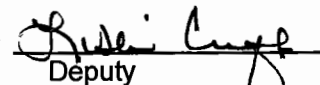
