

Resolution No. 24- 203

Before the Board of Supervisors

of the County of Fresno

In the Matter of Establishing the
Appropriations Limit for the County of Fresno
for Fiscal Year 2024-25

Resolution

WHEREAS, under Article XIII B, section 1, of the State Constitution, the total annual appropriations subject to limitation of the County shall not exceed the appropriations limit of the County for the prior year adjusted for the change in the cost of living and the change in population, except as otherwise provided in Article XIII B of the State Constitution; and

WHEREAS, Government Code section 7910 requires the governing body of each local jurisdiction to annual establish by resolution its appropriations limit for the following fiscal year under Article XIII B of the State Constitution at a regularly scheduled meeting or noticed special meeting; and

WHEREAS, Government Code section 25214.1, subdivision (a), requires that on or before July 1 of each year, the board shall adopt a resolution establishing the appropriations limits for the County Service Areas, if they meet certain qualifications stated in that section; and

WHEREAS, Fresno County Service Areas Nos. 1, 2, 5, 7, 14, 19, 23, 30, 33, 43, and 44 (each a "CSA," and collectively, "CSAs") meet the qualifications in Government Code section 25214.1; and

WHEREAS, the Board of Supervisors ("Board") is the governing body of the County of Fresno ("County") and the CSAs; and

WHEREAS, Government Code section 25214.1, subdivision (b), provides that the Board may include the proceeds of taxes for all county service areas within the County's own appropriations limit; and

WHEREAS, the base year appropriations limit for the County, for Fiscal Year 1986-87, was \$107,238,056; and

1 **WHEREAS**, each fiscal year since the base year, the Board has established the
2 appropriations limit for the County as required by Government Code section 7902, so that the
3 appropriations limit of the County in each fiscal year is equal to the appropriations limit for the
4 prior fiscal year multiplied by the product of the change in cost of living, and the change in
5 population for the calendar year preceding the beginning of the fiscal year for which the
6 appropriations limit is determined, and adjusted for other changes required or permitted by
7 Article XIII B of the California Constitution; and

8 **WHEREAS**, the appropriations limit for the County, including the CSAs, for Fiscal Year
9 2023-24, was established as \$796,389,882; and

10 **WHEREAS**, the appropriations limit for the County for Fiscal Year 2024-25 shall include
11 the CSAs, as stated in Attachment A to this resolution; and

12 **WHEREAS**, for at least 15 days before the date of this resolution, documentation used
13 in the determination of the appropriations limit for the County for Fiscal Year 2024-25 was
14 available for public inspection in the office of the Clerk of the Board and the office of the Auditor-
15 Controller/Treasurer-Tax Collector; and

16 **WHEREAS**, before adopting this resolution, the Board gave the public, including any
17 affected taxpayers, the opportunity to present any evidence or testimony for or against the
18 Board taking such action;

19 NOW, THEREFORE, BE IT RESOLVED:

20 1. Under Government Code section 7901, subdivision (b), the County selects the
21 change in population within the incorporated portion of the County as the “change in population”
22 factor used in the calculation of the appropriations limit for the County for Fiscal Year 2024-25.

23 2. The appropriations limit for the County for Fiscal Year 2024-25 is established as
24 \$831,908,865. That appropriations limit includes the CSAs, as stated in Attachment A to this
25 resolution.

26 3. This resolution is effective immediately upon adoption.


