WHEREAS, the Office of the District Attorney, Organization (Org) 2860 has the opportunity to purchase one vehicle for use during investigations related to the In-Home Supportive Services Fraud program in the current year; and

WHEREAS, the District Attorney, Org 2860 has funds available through Federal passthrough funding received from the Department of Social Services and available Net County Cost for the purchase of one vehicle in the amount of \$35,000; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$35,000 as an Operating Transfer In from District Attorney, Org 2860 to purchase one vehicle; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2020-21 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 ISD - Fleet Services Equipment Org 8911 as follows:
