5610 IN THE AMOUNT OF \$1,951,548 )

WHEREAS, the Department of Social Services requires \$1,951,548 to meet expenditures associated with the new Lease space; and

WHEREAS, the Department of Social Services Organization 5610 will receive \$1,951,548 as an Operating Transfer In from the Welfare Advance Fund Organization 1120 (\$1,745,159) and the Protective Services Subaccount Organization 6210 (\$206,389); and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2017-18 Department of Social Services Organization 5610 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Department of Social Services Organization 5610 as follows:

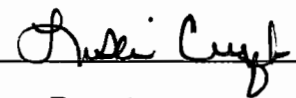
