ORDINANCE NUMBER 21-011

AN ORDINANCE AMENDING SECTION 3800-GENERAL SERVICES OF THE MASTER SCHEDULE OF FEES, CHARGES, AND RECOVERED COSTS FOR THE COUNTY OF FRESNO WHERE SUBSECTIONS 3804, AND 3809-3813 ARE AMENDED.

The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1: The Master Schedule of Fees, Charges and Recovered Costs for the County of Fresno, Section 3800 – General Services, is hereby amended, by amending subsections 3804 and 3809-3813, relating to the recovery of costs of Security, Fleet, and Facility Services of the Internal Services Department (ISD) to County departments and other public agencies, as set forth in Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2: This ordinance shall take effect thirty (30) days from the date of its final passage.
