RESOLUTION AUTHORIZING THE  
FRESNO COUNTY CLERK/REGISTRAR  
OF VOTERS TO PERFORM THE  
ELECTIONS AND BILL FOR  
REIMBURSEMENT OF COSTS

WHEREAS, California Elections Code section 10002, permits the governing board of a city or district to approve and execute a resolution requesting a county's board of supervisors to permit the county elections official to render services relating to the conduct of an election; and

WHEREAS, California Elections Code section 10400 et. Seq., and other laws permit consolidation of elections and sharing of election costs by cities, school districts, other public districts, and other public entities by order of the County Board of Supervisors; and

WHEREAS, the Fresno County Clerk/Registrar of Voters is the county elections official in Fresno County; and

WHEREAS, the Fresno County Superintendent adopted Resolution No. 2021-46 on September 21, 2021, requesting the Fresno County Clerk/Registrar of Voters conduct the April 12, 2022 special election for Fresno Unified School District Trustee Area No. 5 for the remainder of the term ending in 2024; and

1           WHEREAS, the Fresno County Superintendent adopted Resolution No. 2021-53  
2 on October 13, 2021, requesting the Fresno County Clerk/Registrar of Voters conduct  
3 the April 12, 2022 special election for West Park Elementary School District Governing  
4 Board (at large) for the remainder of the term ending in 2022; and

6           WHEREAS, in Resolution No. 2021-46 and Resolution No. 2021-53 the school  
7 districts agree to reimburse the County upon receipt of a bill for all costs incurred by the  
8 Fresno County Clerk/Registrar of Voters in conducting the school districts special  
9 elections.

12           NOW, THEREFORE, BE IT RESOLVED:

- 13           1. The Board of Supervisors authorizes the Fresno County Clerk/Registrar of  
14           Voters to conduct the April 12, 2022, Fresno Unified School District and West  
15           Park Elementary School District elections.

- 17           2. The Board of Supervisors orders the consolidation of the Fresno Unified  
18           School District Trustee Area No. 5 and West Park Elementary School District  
19           (at-large) elections on April 12, 2022.

- 21           3. The Board of Supervisors authorizes the Fresno County Clerk/Registrar of  
22           Voters to bill Fresno Unified School District and West Park Elementary School  
23           District for all costs related to the conduct of the April 12, 2022, Consolidated  
24           Special School District Election.
