WHEREAS, said monies are not included in the FY 2026-27 recommended appropriations and estimated revenues of the Sheriff Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2026-27 Sheriff Organization 3111 as follows:

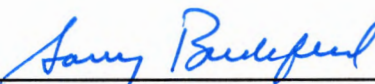
