BEFORE THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO STATE OF CALIFORNIA ORDINANCE NO. <u>21-005</u>

AN ORDINANCE REPEALING ORDINANCE NO.R-450-3751 AND ORDINANCE NO. T-805-363
APPROVING AMENDMENT APPLICATION NO. 3751 AND AMENDMENT TO TEXT APPLICATION
NO. 363 FOR PROPERTIES LOCATED ON THE EAST, WEST, AND SOUTH SIDE OF THE
UNINCORPORATED COMMUNITY OF FRIANT, APPROXIMATELY FIVE MILES NORTHEAST OF
THE CITY OF FRESNO. The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1. Ordinance No. R-450-3751, which was adopted on February 1, 2011, pertaining to Amendment Application No. 3751, and which (1) rezoned the 7.19-acre "Depot Parcel" from Single-Family Residential Agricultural District (R-A) to General Commercial (C-6), (2) rezoned two parcels totaling 6.6 acres from R-A and C-6 to Open Space (OS), and (3) rezoned a 106-acre parcel from AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District to OS, is hereby repealed.

SECTION 2. Ordinance No. T-805-363, which was also adopted on February 1, 2011, pertaining to Amendment to Text Application No. 363, and which adopted the Friant Ranch Zoning Regulations, containing specific zoning districts for the Friant Ranch Specific Plan Area, is hereby repealed.

SECTION 3. Prior to the expiration of fifteen (15) days from the adoption of this Ordinance, it shall be published in accordance with the requirements of Government Code Section 25124 at least one time in the Fresno Business Journal, a newspaper of general circulation in Fresno County.

SECTION 4. In accordance with Government Code Sections 25123, 25131, and 65854-65857, this Ordinance, designated as Ordinance No. <u>21-005</u> shall take effect thirty (30) days after its passage.
