WHEREAS, the Local Health and Welfare Trust Fund 0135, Subclass 13047, 1991 Realign-CalWORKs MOE Org 5247 will receive additional revenues of \$4,755,015 from State of California for unbudgeted sales tax and vehicle license fees revenues to meet unanticipated expenses associated with CalWORKs Org 6310 for FY 2021-22; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the 1991 Realign- CalWORKs MOE Org 5247; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 1991 Realign- CalWORKs Org 5247 as follows:
