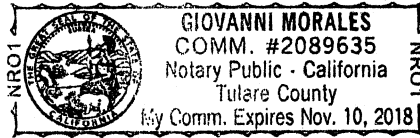

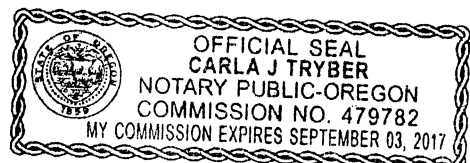

That portion of the Northeast Quarter of Section 35, Township 13 South, Range 22 East, Mount Diablo Base and Meridian, according to the official plat thereof, in the County of Fresno, State of California, described as follows:

COMMENCING at the North Quarter corner of said Section 35; thence, along the North line of said Section 35, North 90°00'00" East, a distance of 1,542.66 feet; thence, leaving said North line, South 00°00'00" East, a distance of 20.00 feet to the TRUE POINT OF BEGINNING;

- 1) Thence, North 90°00'00" East, parallel with and 20 feet South of said North line, a distance of 124.47 feet to the most Northeasterly line of that Parcel of land described in 'Individual Grant Deed' recorded September 09, 1983, Document No. 83083661 of Official Records Fresno County;
- 2) Thence, along said most Northeasterly line, South 18°13'00" East, a distance of 10.53 feet;
- 3) Thence, leaving said most Northeasterly line, parallel with and 30 South of the North line of said Northeast Quarter, a distance of 127.76 feet;
- 4) Thence, North 00°00'00" West, a distance of 10.00 feet to the TRUE POINT OF BEGINNING

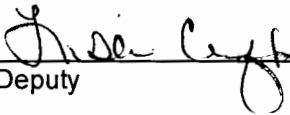
